## **TREASURER'S REPORT**

The office staff is making strong progress in collecting past due assessments in response to 30 day Lien letters that have been sent. As of May 2024 past due dollars are \$240,000 over a period of 8 to 10 years. This is primarily due to deceased owners and living family members not wanting to take ownership. Family members who have taken ownership, pay yearly county taxes & refuse to pay annual property owners association dues, private sales without providing the MCA with closing recorded deeds to transfer ownership, & property purchased on Treasurer's deeds via the State of Az. The buyer is responsible to do their due diligence. Motion to accept the minutes as read, all in favor, none opposed, motion carried.

## **ARCHITECTURAL COMMITTEE**

4 new Social applications were submitted, 3 approved. 5 Architectural request were submitted and 4 approved. 5 complaints were contacted by letter to correct violation(s). Also submitted to the county for review and 2 request for adoption were approved. The Architectural committee is working with the county to correct unsafe properties. All complaint submitted to the MCA are responded to. Violators that continue to refuse corrections are turned over to the county. Containers in Meadview are for temporary storage up to one year while building. Members want clarification on use of cargo containers. When the CC&R's were written they didn't include containers so this needs to bought to the membership to discuss their feelings and what are we going to do about them.

### MR. SMABY

Spoke about the Pierce Ferry Rd & 93 project. The county got together with the tribe and put together a design of that intersection and are trying to get a federal grant of \$17.5 million dollars, that is in appropriation. They feel their going to get that money to move forward. This grant was based on the high fatalities reported. August 20th is the General Plan Amendment is coming up, this is a zoning document that established usage and zoning within the different areas. Meadview, Dolan Springs, & White Hills are all kind of lumped together and the county wants to know how do you want to see your community in the next 10 years? Dolan Springs Double D Market just got their building permits for both a market & deli.
