# Special Notice to All MCA Members Legal Notice of Election

## I. Candidate Eligibility:

A slate of candidates, all of whom are members in good standing of the Meadview Civic Association, shall be selected by a nominating committee. The consent of all candidates shall be obtained before placing their names on the ballot. At the annual meeting a member present may nominate a member for the Board of Governors. No write-in candidate shall be accepted unless nominated at the annual meeting. No member nominated at the annual meeting shall be considered unless the candidate consents to serve if elected. The presiding officer shall limit nominating speeches from the floor to one (1) minute each.

## II. Who May Vote:

Only members in good standing will be eligible to vote. To be a member in good standing means that all association assessments on lots being voted, have been paid in full by **2:00PM, THE FRIDAY PRIOR TO THE ANNUAL MEETING.**

## III. Voting Eligibility:

A person eligible to vote in this election must be the owner or co-owner of Meadview property which is presently being assessed by the Association.

One vote only may be cast for each lot so assessed. Where a lot or lots are owned by one or more persons, only one of the persons named as co-owner may vote for any one lot. Only one vote per lot is allowed.

You may vote by absentee ballot if unable to attend the meeting. You must request your absentee ballot from the Secretary of the Board. Carefully follow the instructions sent with your ballot(s) and return to the Secretary. **ABSENTEE BALLOTS MUST BE RECEIVED BY THE SECRETARY OF THE ASSOCIATION BY THE CLOSE OF THE LAST BUSINESS DAY PRIOR TO THE ANNUAL MEETING.**

## IV. Verification of Voting Eligibility:

Each prospective voter will be required to present proper identification prior to receiving the ballot(s) for voting. Association records will be checked to verify that such person is a member in good standing. Each prospective voter will then be given the specified number of ballots, one ballot for each member lot, and will then cast his/her ballot(s) immediately after verification.

Voting hours shall be from the conclusion of the annual meeting to 2:30 p.m.

There shall be no electioneering within one hundred (100) yards of the polling place.

## V. Ballots for Voting:

Subsequent to verification of eligibility to vote, members will be given one (1) ballot for each lot for which he/she is authorized to cast a vote. Members, after verification of eligibility to vote, and receiving the ballot(s) shall proceed to vote and deposit said ballot(s) in the ballot box within ten (10) minutes. A member voting more than ten (10) ballots shall have multiples of ten (10) minutes for each ten (10) ballots being voted.

## VI. Voting Procedures:

A. In accordance with the desires of the majority of the Association members as expressed at the May 28, 1988 meeting and at the prerogative of the present Board of Governors as authorized in Article III, Section I of the By-Laws of the Association, the number of persons to sit on the Board of Governors shall be five (5).

B. Place an "X" in the box beside the name of each candidate you wish to vote for. On all propositions, place an "X" in the appropriate box. On all proposed By-Law changes mark an X in the appropriate box.

C. Fold your ballot and deposit in the ballot box provided.

NOTE: Voting for more candidates than seats available will invalidate the ballot.

## VII. Ballot Counting:

A. After all the ballots have been cast, the Election Committee will open the ballot box and proceed to count and record the votes.

B. To verify proper performance in all aspects of the election, the election will be monitored by appointed Association members.

## VIII. Installation of Officers:

A. Immediately after the determination of names of the winning candidates, the *newly* elected members will assume their positions on the Board.

B. In accordance with Article III of the Association By-Laws, the Board members will elect executive officers from their own ranks. The executive officers of the Association shall be President, Vice-President, Secretary, Assistant Secretary, Treasurer, and Assistant Treasurer.

C. This Board of Governors shall manage and control the business affairs of the Association in accordance with the terms and conditions of the Articles of Incorporation and the By-Laws of the Association.

## IX Voting by Absentee Ballot:

Members can request an absentee ballot, one for each lot on which an assessment is paid, which will list the slate of candidate dates, Propositions, and the proposed By-Law changes. The request form for absentee ballots should be filled in and mailed to:

Upon receipt of the request form, eligibility and number of votes entitled to be cast will be determined. The ballots) will be mailed to the requester with a return envelope addressed to the Secretary of Board. After indicating your choice of candidates and Bylaw changes, seal the ballot(s) in the envelope addressed to the Secretary. Walk-in Absentee ballots will be accepted until, **2:00PM, THE FRIDAY PRIOR TO THE ANNUAL MEETING.** Absentee Ballots received after **THE FRIDAY PRIOR TO THE ANNUAL MEETING** mail pick-up, will be invalid.

Upon receipt the sealed envelope with the absentee ballot showing the Bar Code of the voter shall be logged in and placed in a locked ballot box. On Election Day, the Election Committee will remove the ballot from the envelope for counting purposes.

**SECTION 3. ASSESSMENTS AND DUES.** The initial fee and the annual assessment are levied for the purpose of acquiring a fund for the construction, improvement, and maintenance of the facilities of the Association, and to provide for the use and enjoyment of the members.

Social Members' dues (Article II. Section 8) is required to assist in defraying current operating costs and maintenance of the facility.

Upon acquiring a lot, the buyer (s) shall pay an initial fee, (except under conditions stated in Article II, Section 2, Paragraph 3) determined by the Board of Governors to be in effect at the time. Should more than one lot be acquired, the initial fee shall be paid for each lot. Upon completing the acquisition of a lot (s) the initial fee must be paid to the Association. Once the initial fee has been paid (except as provided in Article II Paragraph 5) it need not be paid again.

Every membership lot shall be assessed with the payment due on January 31 of each year. Said assessment, if not paid by the due date shall constitute a charge on the lot and shall be a continuing charge until paid. The annual assessment shall not be refundable. A member may neither waive nor otherwise avoid responsibility for an annual assessment.

The assessment shall be, in addition, the personal obligation of the owner (s) of the lot (s) at the time due. The personal obligation shall not pass to a successor entitled unless expressly stated in writing.

Should an outstanding balance not be paid within 30 days of the due date, it shall bear interest at the rate of 1.5% per month on the unpaid balance or a late fee set by the MCA Board. The Association may assign an unpaid balance account to a collection agency. In addition to the unpaid balance all collection fees will be assessed to the unpaid balance. The Association may bring an action at law against the person(s) obligated to pay the annual assessment by filing a lien against the lot (s) in favor of the Association. Such lien shall be continuing until paid. Should the annual assessment remain delinquent, the Association may institute foreclosure proceeding to protect its interest. The prevailing party in an enforcement or foreclosure of lien action shall be entitled to reasonable attorney's fees and costs.

The assessment lien as filed shall be subordinate only to institutional mortgages or trust deeds so recorded.

A sale or transfer of a lot(s) shall not affect the annual assessment charge or lien. At the time of title transfer, the delinquent assessment or lien must be satisfied in which event the Association will execute a release of the charges or lien.

**NEWS OF INTEREST TO MEADVIEW**

The new redistricting maps for legislative and congressional districts have been approved and Meadview residents will be voting for candidates running for a seat in Legislative District 5 and for candidates running for a seat for Arizona Congressional District 4. Our Supervisor District is also 4. The congressional map shows all of Mohave County, except the Hualapai and Kaibab Indian nations, in District 4, but including all of La Paz County and parts of Yavapai, Gila, Pinal, Maricopa and Yuma counties. The new legislative map includes all of Mohave County, except the Indian Nations, and La Paz County. Rep. Nancy McLain was concerned that the congressional district includes parts of Pinal, Gila and Maricopa counties since they are so far away from Mohave they will have nothing in common with Meadview.

Apparently the near 50,000 acres of public land in the Red Lake area is still being pushed by BP Wind Energy. The BLM Environmental Impact Statement may not be completed until March, followed by public hearings, but BP 'sees no impediments to the development'. Project Developer Todd Eagleston of BP says, 'this is a benign project with no impact concerns'. This project will have as many as 235 wind turbines capable of producing up to 350-megawatts of electricity in the first phase and will add another 100 turbines to increase total capacity to 500 megawatts. BP will require tax credits but will not seek grant money or loan guarantees. The generated power will be sold on the grid, meaning it will leave Mohave County and go to the highest bidder, probably Vegas or California.

Traffic detail on Pearce Ferry Road and Diamond Bar Road ends with 56 speeding violations. This was a low tolerance enforcement detail with 54 citations and two warnings. One ticket cited a driver going 71 mph on Diamond Bar Road where the posted speed is 45. Inspections were made on 18 coaches heading to Grand Canyon West resulting in 28 federal violations and three coaches were placed out of service for safety violations.

Mohave County Veterans are in hopes of getting the U.S. Dept of Veterans Affairs interested in opening a Veterans Hospital in the now closed Hualapai Mountain Medical Hospital. Kingman Regional Medical Center has purchased the HMMH building with the knowledge that at the rate Kingman is growing the second hospital will be needed in the near future, but KRMC is listening to this suggestion to open the facility as a Vet Hospital. Kingman has a Veterans Clinic but it is far too small to handle the volume of Veterans currently seeking attention and the travel time to either the Prescott hospital or into Vegas to the Nellis hospital is an additional 2 hours or more. If you are interested in seeing a Vets Hospital here in Kingman, send a letter to the U.S. Depart. of Veterans Affairs, 810 Vermont Ave., NW, Washington D.C., 20420.

The Bureau of Reclamation is announcing the initiation of Phase 4 of the Colorado River Basin Water Supply and Demand. The team is seeking a broad range of options to help resolve future water imbalances in Colorado River water usage. Commissioner Michael Connor has stated that, 'this is a critical study and needs the input from a wide public array.' The study will consider the needs of municipal, industrial and agricultural usage, plus hydroelectric power generation, recreation, fish and wildlife and the ecological systems depending on this river water for the next 50 years. The study will hopefully be finished by July 2012.

The trail along the Colorado River from Laughlin Bridge to Davis Dam is nearly complete, including natural pathways, sidewalk areas, fishing access and restrooms. The site includes several trailheads beginning at the Don Laughlin statue, picnic sites, shade shelters, fishing piers and day-use camp at the base of the Davis Dam. A pedestrian hi way overpass and underpass provides access to this area.

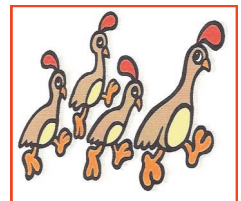

**DATELINE FOR MCA****By Suzann Newell**

**2001**---Mt. Tipton became part of Kingman Unified School District, classes include K thru 12. Area phone number is 928. Discussion on paving Diamond Bar Road is including Meadview residents. Diesel is now available in the Meadview Market. DSL arrived in Meadview. A tourist helicopter crashed on the cliffs east of town. GMFD set up the staging area and provided GPS readings for the air evacuation of the injured. Seven were killed. 1st Classic Car Show sponsored by the Area Chamber was held in October.

**2002**---Hoover Dam bypass bridge construction started with the finish date set for spring of 2007. Lake level is down to 1174 with another 14 foot drop expected. A tile Welcome to Meadview sign is proposed by COM. Newsome Tile Company will provide the artistic painted tiles.

**2003**---Gary Wiens sold Meadview Market to Trent and Tracy Van Wormer. Hoover Dam Bridge will cost \$5.9 million more. Lake level is 1139, expected to reach 1118 by end of year. Action Builders and Hardware closed its doors. 200 stops signs have been placed at Meadview intersections.

**2004**---COM President Blair Berg announced a CERT team is up and ready for any mass emergency. COM Advertiser covers local news and ads. Local Adopt-a-Highway teams clean 28 miles of road on Stockton Hill and Pearce Ferry Road. Meadview Basin, which supplies water for LMC and Meadview, is 6 to 7 miles wide, 16 miles long with a water level of 240 feet, declining at an average rate of about 1 foot a year. Paving started on Stockton Hill Road. The Chamber sponsored an Ugly Truck Parade and held a Quad Rally/Poker Run. Lake level is 1125.

**2005**---Meadview Hardware, owned by Van Wormer and Levandowski opened. The post office located at the back of the store with its own entrance is open 5 days a week. Lake Mead Plaza opens. Bill and Susan Kaufmann owners. The Meadview Area Chamber moved into the Plaza. SCAT members complete training and will help patrol Grapevine Mesa and help the Sheriff's Department by providing traffic control at accident scenes. The County Maintenance yard is now completed and men stationed in Meadview will maintain the roads in Meadview. Buffalo (American Bison) have been sighted at Rampart Overlook. Heavy rains provided a real Red Lake that lasted until early summer. Lake Mead has receded from Pearce Ferry leaving a humpy but walk able area to reach mile 279 on the Colorado River Guide.

**2006**---Paving of Stockton Hill road was finished! This provided a 12 mile shortcut to Kingman. Meadview Library continues to hold used book sales, raffles of quilts and jewelry and the sale of local authors' books to raise money for a 2nd building. Pearce Ferry Rapids are visible at mile 279 on the Colorado River.

**2007**---A BIG freeze broke enough pipes in town to lose 500,000 gallons of water. Many pipes in homes froze and some homes were without water for three days. If the census of 2010 counts 200,000 residents in Mohave County, the three member Board of Supervisors will go up to five members. Meadview was featured on Channel 3 out of Phoenix on the GOOD MORNING ARIZONA show. The Grand Canyon West Skywalk opened in March with Buss Aldrin taking the first step. Thieves, cutting copper power lines, miscalculated and dropped a pole on their truck which shorted out the entire system. And burned up the truck. Meadview was without power for four hours. Heavy rain washed out many low areas on Diamond Bar Road, and sections of Stockton Hill Road. Pearce Ferry Rapids were getting rougher with a define drop off in the curve. A microburst of wind damaged bridge piers at Hoover Dam and will delay completion of the bypass bridge.

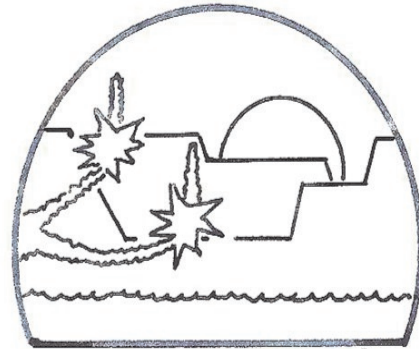

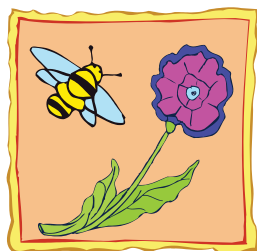
