PRESIDENT'S LETTER

November/December 2014

As we are nearing the end of 2014, the Board and I feel we have made a significant progress in handling affairs for your organization. In May 2013, when taking the reins of the MCA, we were faced with many difficult and unresolved issues.

Of immediate concern was the lack of sufficient funds to cover our expenses until the end of this year (2014). The office had an abundance of problems, of a major concern was our outdated and problematic computer system.

Through their hard work, diligence and creative thinking, our office staff has been able to resolve many of those issues for us. Not the least of which was the collection of a large amount of past due assessments that have been on the books as "uncollectible" for some time. Because of the collection of these additional funds, we are now able to meet our monthly obligations until the end of 2014.

As you will recall during last May's election, the membership voted for a new air conditioning system to be installed in our facility. However, at the same time, the dues "increase" of \$10 was voted down, resulting in absolutely no funds to cover the cost of that air conditioning resolution. We are continuing to put the air conditioning project in the forefront of our objectives. Should we be able to collect additional, and adequate, funds, those dollars will be earmarked for the air conditioning project.

The flooring in two bathrooms has been replaced, thus eliminating a hazard to our members. Our efficient and hardworking security and maintenance staff are continually working to ensure the enjoyment and safety of our facilities.

Several Board members have updated our Policies & Procedures Manual, which was extremely obsolete. An Office Procedure Manual is being created for easy reference of the duties of our staff. As you can see, we are constantly working to serve you, our membership, to the best of our ability.

At this time, I would like to invite, and urge, any eligible MCA member to consider running for the Board in the May 2015 Election. There will be two positions open to make up our Seven Member Board. Applications will be available from December 1, 2014, and must be submitted by February 15, 2015. You may contact our office staff for information and an application. Applications will also be available on our website and in this Monitor issue.

As always, it is a privilege to represent you.

Special Notice to ALL MCA Members Legal Notice of Election

I. Candidate Eligibility:

A slate of candidates, all of whom are members in good standing of the Meadview Civic Association, shall be selected by a nominating committee. The consent of all candidates shall be obtained before placing their names on the ballot. At the annual meeting a member present may nominate a member for the Board of Governors. No write-in candidates shall be accepted unless nominated at the annual meeting. No member nominated at the annual meeting shall be considered unless the candidate consents to serve if elected. The presiding officer shall limit nominating speeches from the to one (1) minute each.

II. Who May Vote:

Only members in good standing will be eligible to vote. To be a member in good standing that all association assessments on lots being voted, have been paid in full by **2 P.M., THE FRIDAY PRIOR TO THE ANNUAL MEETING.**

III. Voting Eligibility:

A person eligible to vote in this election must be the owner or co-owner of Meadview property which is presently being assessed by the Association.

One vote only may be cast for each lot so assessed. Where a lot or lots are owned by one or more persons, only one of the persons names as co-owner may vote for any one lot. Only one vote per lot is allowed.

You may vote by absentee ballot if unable to attend the meeting. You must request your absentee ballot from the Secretary of the Board. Carefully follow the instructions sent with your ballot(s) and return to the Secretary. **ABSENTEE BALLOTS MUST BE BY THE SECRETARY OF THE ASSOCIATION RECEIVED BY THE CLOSE OF THE LAST BUSINESS DAY PRIOR TO THE ANNUAL MEETING.**

IV. Verification of Voting Eligibility:

Each prospective voter will be required to present proper identification prior to receiving the ballot(s) for voting. Association records will be checked to verify that such person is a member in good standing. Each prospective voter will then be given the specific number of ballots, one for each member lot, and will then cast his/her ballot(s) immediately after verification.

Voting hours shall be from the conclusion of the annual meeting to 2:00 p.m.

There shall be no electioneering within one hundred (100) yards of the polling place.

V. Ballots for Voting: Subsequent to verification of eligibility to vote, members will be given one (1) ballot for each lot for which he/she is authorized to cast a vote. Members, after verification of eligibility to vote, and receiving the ballot(s) shall proceed to vote and deposit said ballot(s) in the ballot box within ten (10) minutes. A member voting for more than ten (10) ballots shall have multiples of ten (10) minutes for each ten (10) ballots being voted.

VI. Voting Procedures:

A. In accordance with the desires of the majority of the Association members as expressed at the May 28,

1988 meeting and at the prerogative of the present Board of Governors as authorized in Article III, Section I of the By-Laws of the Association, the number of persons to sit on the Board of Governors shall be seven (7).

B. Place an "X" in the box beside the name of each candidate you wish to vote for. On all propositions, place an "X" in the appropriate box. On all proposed By-Laws changes mark an "X" in the appropriate box.

C. Fold your ballot and deposit in the ballot box provided.

NOTE: Voting for more candidates than seats available will invalidate the ballot.

VII. Ballot Counting:

A. After all the ballots have been cast, the Election Committee will open the ballot box and proceed to count and record the votes.

B. To verify proper performance in all aspects of the election, the election will be monitored by appointed Association members.

VIII. Installation of Officers:

A. Immediately after the determination of names of the winning candidates, the newly elected members will assume their positions on the Board.

B. In accordance with Article III of the Association By-Laws, the Board members will be elect executive officers from their owns ranks. The executive officers of the Association shall be President, Vice-President, Secretary, Assistant Secretary, Treasurer, and Assistant Treasurer.

C. This Board of Governors shall manage and control the business affairs of the Association in accordance with the terms and conditions of the Articles of Incorporation and the By-Laws of the Association.

IX. Voting by Absentee Ballot:

Members can request an absentee ballot, one for each lot on which an assessment is paid, which will list the slate of candidate dates, Propositions, and the proposed By-Law changes. The request form for absentee ballots should be filled in and mailed to:

Upon receipt of the request form, eligibility and number of votes entitled to be cast will be determined. The ballot(s) will be mailed to the requester with a return envelope addressed to the Secretary of the Board. After indicating your choice of candidates and By-Law changes, seal the ballot(s) in the envelope addressed to the Secretary. Walk-in Absentee ballots will be accepted until, **2 P.M., THE FRIDAY PRIOR TO THE ANNUAL MEETING.** Absentee Ballots received after **THE FRIDAY PRIOR TO THE ANNUAL MEETING** mail pick-up, will be invalid.

Upon receipt the sealed envelope with the absentee ballot showing the Bar Code of the voter shall be logged in and placed in a locked ballot box. On election Day, the Election Committee will remove the ballot from the envelope for counting purposes.

BLAST FROM THE PAST Meadview Monitor, November 1966.**LAKE MEAD HAS A NEW COMMUNITY - Meadview Terrace To Feature Paved Streets and Utilities.**

Developers, Frank Glindmeier and Paul Mullane today jointly announced the official opening of the Meadview Terrace subdivision.

The new acres, with 402 developed lots, is the result of six years of planning and developing on the Meadview project.

In making the announcement, Glindmeier stated "We have wanted to start a development, such as Meadview Terrace, for some time, so that we could offer utilities, paved streets and all of the advantages of urban living. Until this time, it was not economically feasible however. The existing lake access at Pierce Ferry Landing was always subject to being cut off if the lake level receded such as it has done during the past few years. With the completion of the South Cove Road we now have guaranteed access to Lake Mead for all time, regardless of lake level, and the feasibility of a fully developed community is now evident.

It was learned from Paul Mullane that "Meadview Terrace is the first development of an overall planned community at Meadview. We are sure that there will be more developed properties available later, but we know that they are slightly further from the lake and assuredly more expensive," Mullane went on to say, "We have made every effort to make these first Meadview Terrace lots available at the lowest possible cost. The initial development costs on a project of this kind are staggering, and we have not tried to amortize these entire costs into the Meadview Terrace project alone. If we were to have done so the prices would be nearly double what they are today.

Until this time, there has never been any developed property available for sale at Lake Mead. In the first place, there is virtually no private land available within a usable distance of the lake, and most of what little is available is unsuitable for development of this type. Glindmeier said, "We know of no other land in either Arizona or Nevada that is available for private development such as Meadview. Meadview will certainly be a 'one of a kind' development."

Glindmeier continued, "Perhaps Meadview's greatest asset is the fact that the entire community is surrounded by Federal land, providing a shelter and a park like setting for all time. Where can you find

a community where elbow room and community recreation space is available on such a large scale? This is one reason we have made the lots larger than in most developments of this type. This is a beautifully vast country and to overcrowd it within the subdivision itself would be a gross mistake."

Property restrictions have been recorded for Meadview Terrace and insure an attractive orderly growth for the community. Included in the restrictions is a paragraph regarding site grading. Paul Mullane pointed out that, "The worst thing that could happen to this beautiful country is to have people come in and strip the land of its beautiful natural growth. We have insisted that all site grading be held to an absolute minimum. Obviously a certain amount of grading has to be done in order to clear a site for either a permanent home, but needless defacing of the landscape hurts everyone in the community and will not be tolerated."

The beautiful Joshua setting is highlighted by a magnificent view to the east of the Grand Wash Cliffs which rise to a height of approximate of 5600 feet. Harold Brown, Project Manager for Meadview, stated, "I think the biggest problem that residents are going to have at Meadview is in trying to decide which direction to face their house or mobile home.

The country is so pretty, and there are so many beautiful views in each direction, that a person is inclined to try to take advantage of all of the views at one time. Of course, this isn't practical, but there are some little secrets as to how you can get the most out of your site development program. I want to try to be of assistance to all of our residents in working with them to get the most out of their site orientation. After living in this country for quite a few years now, I have become familiar with a lot of site development secrets that might not be readily apparent to someone visiting this area for the first time."

The formal grand opening of the Meadview Terrace development will take place between Saturday, December 24th and Sunday, January 1st. Sales have been officially opened as of this date however, and advertising of the project is underway. In the January/ February issue of the Meadview Monitor the next "Blast from the Past" will include "Meadview Marina to Sponsor Fishing Scoreboard."

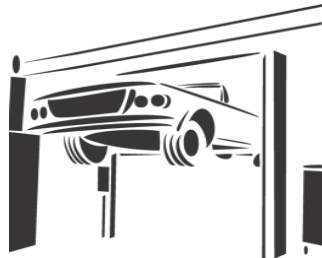

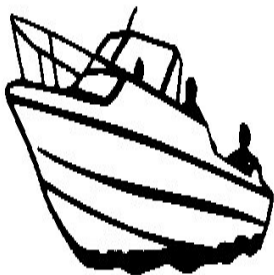

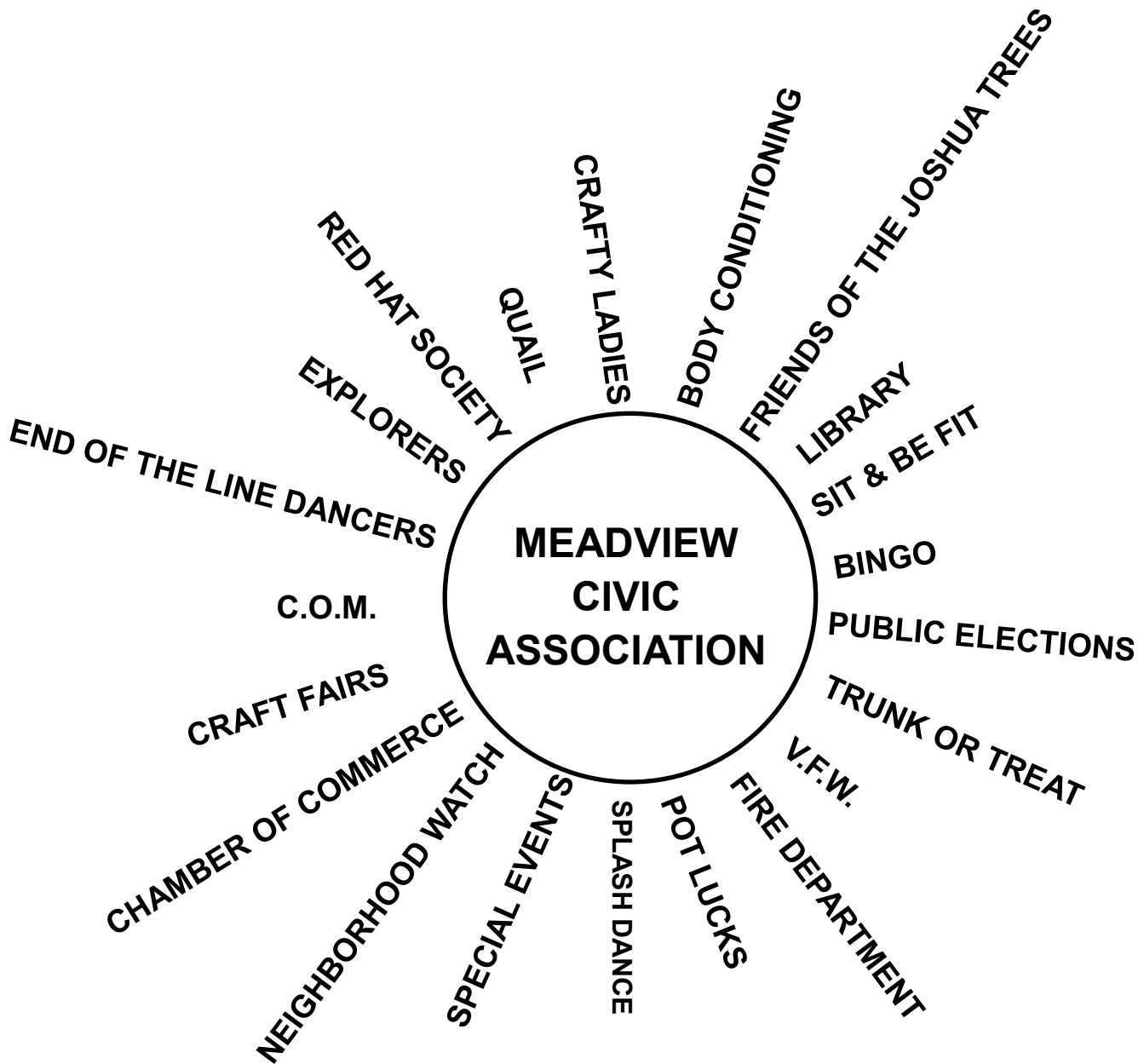
